Remembrance Day is fast approaching so its time again to plan for both RSL Sub Branches and RSL Art Union Direct Sales teams' fundraising in the 2 weeks leading up to November 11^{th} 2022. This will cover the period of 31^{st} October to 6^{th} November and 7^{th} to 13^{th} November.

Co-Fundraise on 1 site





- RSL Art Union secures a shopping centre at your request and uses this with an RSL Sub Branch. A configuration of 1 x RSL Art Union fundraiser and 1 x RSL Sub Branch member utilising the same RSL Art Union kiosk booth.
- We aim to book the largest paid site available for 2 x RSL Art Union kiosk booths allowing both fundraiser and member have space for their equipment and/or merchandise.

Co-Fundraise on 2 sites











- RSL Art Union secures a shopping centre at your request with 2 total sites (1 paid site and 1 community site).
- RSL Sub Branch members are welcomes to share these with RSL Art Union in a configuration of 1 x RSL Art Union fundraiser and 1 x RSL Sub Branch member at each site; or 2 x Art Union fundraisers at the paid site and 2 x Sub Branch members at the community site.

Independent Fundraising



If any Sub-Branches have/are looking to secure their own community site within a shopping centre and wish to ensure they have exclusive use of that centre during these two weeks, please let us know within the below timeframes and we will re-arrange any bookings we had intended to use.

RSL Art Union sites will be set up with cause banners and the kiosk booth only. Any Co-fundraising plans will be coordinated directly with the Sub Branch based on their preference of location and shopping centre. RSL Art Union will ensure shopping centre guidelines for site setup are communicated in advance.

RSL Art Union Direct Sales fundraisers may use sites outside standalone newsagents, IGA's, pharmacies etc (Alt sites) during this period. These fundraisers will be redirected to other locations if a Sub Branch indicates they will use this area.
